## MULTI-MEDIA PARENTAL RELEASE

HAS ABSOLUTE RIGHT AND PERMISSION TO COPYRIGHT AND/OR PUBLISH PHOTOGRAPHIC PORTRAITS OR PICTURES OF MY CHILD, IN WHICH I MAY BE INCLUDED IN WHOLE OR PART, OR COMPOSITE OR DISTORTED IN CHARACTER FORM IN CONJUNCTIONS WITH MY OWN OR A FICTITIOUS NAME OR REPRODUCTIONS THEREOF IN COLOR OR OTHERWISE, MADE THROUGH ANY MEDIA AT THEIR DISPOSAL FOR ART, ADVERTISING, TRADE OR ANY OTHER LAWFUL PURPOSE WHATSOEVER. I HEREBY WAIVE ANY RIGHT THAT I MAY HAVE TO INSPECT AND/OR APPROVE THE FINISHED PRODUCT OR THE ADVERTISING COPY THAT MAY BE USED. I HEREBY RELEASE, DISCHARGE, AND AGREE TO SAVE DANCE DIMENSIONS J&T, INC. AND ALL AFFILIATES, FROM ANY LIABILITY BY VIRTUE OF ANY BLURRING, DISTORTION, ALTERATION, OPTICAL ILLUSION, OR USE IN COMPOSITE FORM, WHETHER INTENTIONAL OR OTHERWISE, THAT MAY OCCUR OR BE PRODUCED IN THE TAKING OF SAID PICTURES, OR IN ANY PROCESSING TENDING TOWARDS THE COMPLETION OF THE FINISHED PRODUCT.

## FINANCIAL AGREEMENT

I/WE UNDERSTAND THAT THE POLICY OF DANCE DIMENSIONS J&T, INC., TO MAKE NO REFUND WHATSOEVER ON REGISTRATION OR ASSOCIATED FEES. I/WE UNDERSTAND THAT THE REGISTRATION FEE PAID FOR EACH CHILD IS USED TO OFFSET SERVICES RENDERED IN CONNECTION WITH PROCESSING MY CHILD'S APPLICATION FOR ADMISSION TO THE CAMP.

I/WE UNDERSTAND THAT ALL SUMMER CAMP REGISTRATION PAYMENTS MUST BE MADE IN ADVANCE. I/WE UNDERSTAND THAT IF I HAVE REGISTERED MY CHILD TO ATTEND ANY DAY OR WEEK OF CAMP, I AM RESPONSIBLE TO PAY FULL TUITION. IF MY CHILD DOES NOT ATTEND THE CAMP, I AM RESPONSIBLE FOR PAYING THE FULL TUITION. THE CAMP REGISTRATION CAN BE TRANSFERRED TO ANOTHER CHILD WITH NOTICE TO DANCE DIMENSIONS J&T, INC AND OTHER CHILD'S GUARDIAN SIGN THE PARENT AGREEMENT.

I/WE UNDERSTAND LATE FEES WILL BE INCURRED WHEN MY CHILD IS ON SCHOOL PROPERTY AFTER CAMP DISMISSAL TIMES. IF A CAMPER IS PICKED UP LATE, I/WE UNDERSTAND THAT A FEE OF \$2.00 FOR

EVERY 1 MINUTE THAT THE CHILD IS ON PREMISES AFTER END TIME. I/WE UNDERSTAND MY CHILD WILL NOT BE ADMITTED TO THE CAMP WITH ANY UNPAID LATE PICK-UP, TUITION OR OTHER FEES. IMPORTANT: SIGNATURES OF ONE PARENT OR GUARDIAN CONSTITUTE AS AN AGREEMENT FOR ALL PARENTS OR GUARDIANS.

### **DROP OFF / PICK UP**

WE ASK THAT ALL CAMPER ADHERE TO THE SCHEDULE OF THE DAY CAMP THAT HAS BEEN SIGNED UP FOR: FULL DAY CAMP IS 7:45 - 5:15PM, MORNING HALF DAY - 7:45AM - 12:00PM, AFTERNOON HALF DAY - 1:00PM - 5:15PM. IF YOU WILL BE LATE OR EARLY TO DROP OFF OR PICK UP, WE ASK THAT YOU LET US KNOW. EACH CAMPER WILL BE PLACED IN GROUPS AND WILL IMPACT THE REST OF THE GROUP THEY, IF THEY ARE NOT AT THEIR SCHEDULED DROP OFF TIMES TO PARTICIPATE. PLEASE MAKE EVERY EFFORT FOR THE CAMPER TO ATTEND THE SIGNED UP CAMP TIMES. CAMPER WILL HAVE TIME FOR BREAKFAST, LUNCH AND SNACK IN EACH DAY. PLEASE PACK THEIR MEALS, SNACKS, DRINKS/WATER WITH THEM AS DANCE DIMENSIONS WILL NOT BE PROVIDING FOOD/DRINKS. WE HAVE WATER REFILLS, BUT PLEASE HAVE CAMPER BRING THEIR WATER BOTTLE.

### **BEHAVIOR MANAGEMENT AND DISCIPLINE POLICY**

THE GOAL OF THIS POLICY IS NOT TO SET UP CONSEQUENCES AND PUNISHMENTS FOR STUDENTS WHEN THEY MISBEHAVE, BUT RATHER TO ESTABLISH POSITIVE EXPECTATIONS FOR STUDENT BEHAVIOR. A SECOND GOAL OF THIS POLICY IS NOT ONLY TO ADDRESS THE OUTWARD BEHAVIOR OF THE STUDENTS, BUT ALSO TO TRANSFORM THEIR HEARTS AND MINDS SO THEY UNDERSTAND HOW TO INTERACT WITH OTHERS. THE RULES OF THE CAMP ARE REFLECTED IN THESE 3 PRINCIPLES:

1. SAFETY
2. RESPECT PROPERTY OF THE CAMP AND OF OTHERS
3. HAVE FUN

### **DISCIPLINARY ACTIONS\***

FIRST OFFENSE: OFFENSE NOTED AND CONVERSATION WITH PARENT

SECOND OFFENSE: CAMPER WILL BE RESTRICTED FROM SOME CAMP ACTIVITIES. A CALL MADE TO PARENTS TO INFORM THEM OF THEIR CHILD'S BEHAVIOR AT THE CAMP.

THIRD OFFENSE: FURTHER RESTRICTIONS IMPOSED WHICH MAY INCLUDE EXCLUSION FROM ATTENDANCE. A CALL TO THE STUDENT'S PARENTS TO INFORM THEM OF THEIR CHILD'S BEHAVIOR AT THE CAMP.

FOURTH OFFENSE: CAMPER MAY BE REMOVED FROM CAMP ATTENDANCE.

\*ANY OF THESE STEPS MAY BE SKIPPED AT THE DISCRETION OF THE CAMP STAFF BASED UPON THE FREQUENCY AND SEVERITY OF THE CAMPER'S MISBEHAVIOR.

**RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

**IN CONSIDERATION OF BEING PERMITTED TO PARTICIPATE IN ALL ACTIVITIES AT DANCE DIMENSIONS CAMP, THE UNDERSIGNED, FOR HIM OR HERSELF AND ANY PERSONAL REPRESENTATIVES, HEIRS, AND NEXT OF KIN, HEREBY AGREES TO THE FOLLOWING:**

- 1. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES, AND COVENANTS NOT TO SUE DANCE DIMENSIONS, J&T, INC., ITS OFFICERS, EMPLOYEES, AGENTS, AND REPRESENTATIVES (HEREINAFTER REFERRED TO AS "RELEASEES") FROM ALL LIABILITY TO THE UNDERSIGNED, HIS PERSONAL REPRESENTATIVES, ASSIGNS, HEIRS, AND NEXT OF KIN FOR ANY LOSS OR DAMAGE AND ANY CLAIMS OR DEMANDS THEREFORE ON ACCOUNT OF INJURY OR DEATH OF THE UNDERSIGNED OR PROPERTY LOSS OR INJURY, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, WHILE THE UNDERSIGNED IS PARTICIPATING IN DANCE DIMENSIONS CAMP ACTIVITIES**
- 2. THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS THE RELEASEES AND EACH OF THEM FROM ANY LOSS, LIABILITY, DAMAGE, OR COST HE OR SHE MAY INCUR DUE TO THE UNDERSIGNED'S PARTICIPATION IN DANCE DIMENSIONS J&T INC. CAMP ACTIVITIES WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.**
- 3. THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE DUE TO THE NEGLIGENCE OF RELEASEE OR OTHERWISE WHILE PARTICIPATING IN DANCE DIMENSIONS J&T, INC CAMP ACTIVITIES.**

**THE UNDERSIGNED FURTHER EXPRESSLY AGREES THAT THE FOREGOING RELEASE, WAIVER, AND INDEMNITY AGREEMENT IS INTENDED TO BE AS BROAD AND INCLUSIVE AS IS PERMITTED BY THE LAW OF THE STATE OF CALIFORNIA AND THAT IF ANY PORTION THEREOF IS HELD INVALID, IT IS AGREED THAT THE BALANCE SHALL, NOTWITHSTANDING, CONTINUE IN FULL LEGAL FORCE AND EFFECT.**
